Drug Policy Action Plan of the Capital City of Prague for the period 2008 - 2009

Introduction:

The Drug Policy Action Plan of the Capital City of Prague for the period of 2008 to 2009 completes the Drug Policy Strategy of the Capital City of Prague for the period of 2008 to 2012 and is concretizing its activities.

The Drug Policy Strategy of the Capital City of Prague (further on as "the Strategy") relays on previous strategic materials of the City, on analyses effectuated with regards to the evolution in services, coordination, and funding as well as on the drug scene. With this respect the annual reports on realization of Drug Policy for the precedent years processed by the Regional Department of the Drug Prevention were appreciated as valuable background materials.

The Strategy and the related Action Plan (further on as "the AP") are in step with the basic conceptual materials, which are the National Drug Policy Strategy for the period 2005 to 2009 and the Action Plan for the realization of the National Drug Policy Strategy for the period of 2007 to 2009.

The individual objectives of the AP for the period 2008 - 2009 comply with the following criteria:

- objectives are real and measurable
- objectives are effective with respect to their funding and directly contribute to attain the principal objectives of the Policy
- the number of objectives in given areas is realizable

The principal objective of the Policy:

To reduce the use of all types of drugs and the potential risks and damage that can afflict individuals and society due to the drug use through the use of following strategies:

The AP was prepared for the period 2008 - 2009 and will be assessed in its time. Following an assessment of individual measures a new AP for the period of 2010 - 2011 will be prepared.

The AP is approved by the Drug Commission of the Council of the CCP and the Council itself. The plan defines the responsibilities of coordinators for the reaching of objectives. For the individual areas of the AP (education, health and social areas) are held responsible the relevant politicians, heads of divisions, departments and individual organizations.

Individual points of the AP were prepared with the contribution of the Drug Commission of the Council of the CCP (further on as "the PK RHMP"), specialized sections by the PK RHMP (further on as "Sections") and the Regional Department of the Drug Prevention (further on as "KOPPR").

Technical and organizational objectives

In order to achieve the specific objectives, it is necessary to improve the quality of the current system and to create a corresponding and functional organizational setting for the implementation of the set of the Capital City of Prague (further on as "the CCP") Drug Policy measures based on multidisciplinary cooperation. Unless these objectives attained, it would not be possible to expect any effective achievement of specific and main objectives.

1) Efficient Funding – multi-annual funding of programs constituting the basic network of services in the CCP. To continue with multi-annual funding of the programs needed on the basis of a needs analysis that would complete the service network and be based on verified scientific knowledge and also would be realized by qualified professionals.

2) Coordination at the CCP – to create enough space, in particular the personnel availability for the coordination of drug policy with respect to the volume of activities in the given action plans that would emphasize on analyses, report evaluations and the use of scientific background materials.

To improve the effectiveness of the system of primary prevention coordination in the area of education and to support it formally. Through the efforts of attaining the objectives of the program Health 21 to involve actively the divisions of the MHMP into the realization of drug measures and of other measures in the field of prevention and treatment of drug users.

3) Public Awareness – to provide objective, evidence-based information to the general public.

4) Evaluation of Activities – activities should be regularly evaluated on all levels and gained knowledge applied in practice. The Strategy will be evaluated in the relation to the AP.
